## 2015 NorthBay Wilderness First Responder's Terms & Conditions

**Payment & Cancellation:** NorthBay will accept no less than 30% of the total Wilderness First Responder cost at the time of registration to reserve your cabin. This deposit is **NON-REFUNDABLE**. The remaining balance payment is due no later than March 2, 2015. Failure to make final payment NorthBay will consider your reservation void and release your cabin reservation for potential alternate Wilderness First Responder Registrant bookings.

**Rules & Regulations:** The individuals named on the Wilderness First Responder Registration Form agree to abide to all of the rules and regulations established by NorthBay Adventure Camp. All Wilderness First Responder Registrant will be given a verbal NorthBay safety orientation at the beginning of the course.

1. All Wilderness First Responder Registrants will be required to have a properly completed and signed NorthBay Health and Liability Release Form.
2. The user group must leave the property, including individual rooms, in a clean condition.
3. Guest pets and skateboards/longboards are not permitted on the property.
4. The illegal use of the following are never permitted on the property: alcoholic beverages, illegal drugs, firearms, dangerous knives, weapons, fireworks or explosives.
5. Smoking is not permitted in any of the restrooms, cabins or other buildings. Smoking cigarettes and cigars will be limited to various designated smoking areas only.

Campers will conform to all directives of NorthBay and all NorthBay's staff especially in the areas regarding the safety and well-being of each Wilderness First Responder Registrant. Failure to comply with NorthBay's rules and regulations can result in immediate termination of the Wilderness First Responder Registrant's stay at NorthBay and forfeiture of all payments to NorthBay.

**Personal Property/Belongings:** NorthBay is not responsible for any Wilderness First Responder Registrant's personal property or belongings while in transit to or from NorthBay nor while staying at NorthBay.

**Damage to NorthBay Property:** Each Wilderness First Responder Registrant will agree to pay for any damages to the property, including but limited to graffiti, buildings, facilities, and equipment or loss of NorthBay equipment that arises out of the Wilderness First Responder Registrant's use of NorthBay.

**Dismissal of Wilderness First Responder Registrant (s):** NorthBay retains the right to require that a guest be dismissed from the premises should that guest not abide by the guidelines, rules, or policies in force. The group will be responsible for the safe transportation of any dismissed guest. Should you be dismissed from NorthBay – no refund will be provided.

**Medical Care:** NorthBay's nurse will be available for first aid and distribution of over-the counter medications. Care provided by the NorthBay nurse is included in your Wilderness First Responder registration. Should any Wilderness First Responder Registrant require outside medical care, all expenses will be the financial responsibility of the Wilderness First Responder Registrant. Emergency medical care will be provided by calling local 911 services. Use of the NorthBay nurse is at the Wilderness First Responder Registrant's discretion and the Wilderness First Responder Registrant holds NorthBay harmless from and damages resulting from the care.

**Images, Etc.:** Permission is given to NorthBay to use pictures, videos, music, audio recordings created by NorthBay or pictures, video, music, art, audio recordings created by any Wilderness First Responder Registrant that originated from NorthBay or NorthBay Wilderness First Responder Registrant Activity.

The Wilderness First Responder Registrant must adhere to the guidelines of NorthBay above, posted on the grounds or published in the registration information.
